### Fees and charges

Appendix №4 to DISCRETIONARY MANAGEMENT TERMS OF BUSINESS

Description	Charge <sup>1</sup>
Minimum annual fee	10 000 (ten thousand) US Dollars per year
	or, in case the strategy currency is not US Dollars, equivalent thereof in another currency at the exchange rate determined by ACM acting in good faith

#### Minimum annual fee calculation procedure:

- The Minimum annual fee is not applicable under the Discretionary Management Agreement if an Investment Services Agreement incorporating the ACM General Investment Services Terms of Business is entered into between ACM and the Client and in force, in which case the Minimum annual fee will be calculated and paid under Appendix 3 to Investment Services Terms of Business.
- If the Investment Services Agreement is terminated in the course of a year and the Discretionary Management Agreement entered into between ACM and the Client is in force on the date of such termination, the Minimum annual fee shall continue accruing under the Discretionary Management Agreement.
- The calculation of the Minimum annual fee includes management services fee and performance fee for all the strategies unless indicated otherwise and any other applicable fees as determined by ACM.
- The Minimum annual fee is paid on a yearly basis in January following the reporting year as well as on the date of termination of the Discretionary Management Agreement.
- The Minimum annual fee shall start accruing from the date when the first funding was credited by the Client to any of Client's accounts opened with ACM under the Discretionary Management Agreement.
- If the first funding was credited by the Client or the Discretionary Management Agreement is terminated in the course of a year, the Minimum annual fee will be calculated pro rata temporis at the end of the relevant year or on the date of termination accordingly.

• For the avoidance of doubt, regardless of the number of strategies chosen by the Client, the maximum amount of Minimum annual fee payable by the Client under the Discretionary Management Agreement per year shall not exceed 10 000 (ten thousand) USD (or its equivalent in another currency as described above).
